**AMOUNT:** 5- \$1,000 competitive scholarships

**CRITERIA:**

- Cumberland County Schools high school senior
- Minimum 2.5 unweighted GPA
- Career & Technical Education Concentrator (This includes students completing a CTE Certificate at FTCC through High School Connections.)
- Demonstrated need
- Enrollment in a **North Carolina Community College within one year of high school graduation** to pursue an associate degree

**DEADLINE:** Eligible students must submit the completed application and attachments to their CTE Facilitator or counselor by **Friday, April 13, 2018**

**REQUIRED ATTACHMENTS:**

- Include a one-page, typed statement that answers these questions:
  - What are your career goals?
  - What are your academic plans after high school?
  - What school/community activities have you participated in within the past two (2) years?
  - Have you received any awards/honors that you would like to discuss?
  - Why is this scholarship a financial necessity for you?
- Please attach a copy of your official high school transcript
- You may provide a copy of your Estimated Family Contribution (EFC) statement from your FASFA. If you are not able to secure this information by the application deadline, you may provide other proof of annual household income.

**The application form may be typed or neatly hand-written. Attachments will be accepted provided the total package does not exceed five (5) pages.**
